

ORDINANCE NO. 95-2015 (CRR), *Second Reading*

An Ordinance amending the use regulations and rates for admission and other services for the Cleveland Heights Community Center and parks for the 2015-16 fall/winter season, and repealing Ordinance No. 95-2014.

WHEREAS, the City of Cleveland Heights annually reviews its use regulations and rates for admission and other services for its Community Center and parks; and

WHEREAS, in anticipation of the 2015-2016 fall/winter season, it is deemed desirable to reaffirm the 2014-2015 regulations.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cleveland Heights, Ohio, that:

SECTION 1. Ordinance No. 95-2014 be and is hereby amended to henceforth read as follows:

ADMISSION AND USE - COMMUNITY CENTER ICE RINKS

(a) Except as otherwise provided herein, admission to the Cleveland Heights Community Center Ice Rinks building and the use of such Ice Rinks shall be limited to bona fide legal residents of the City of Cleveland Heights who are authorized holders of a proper Recreation Identification Card issued by the City of Cleveland Heights, or an authorized guest of the holder of such a Recreation Identification Card, or to non-residents properly registered with organized ice programs or who pay authorized non-resident rates for ice programs.

(b) Recreation Identification Cards shall be issued only to Cleveland Heights residents.

(c) Each holder of a Recreation Identification Card shall be entitled to purchase not more than three (3) guest tickets for each public skating session. This may be limited from zero (0) to three (3) as deemed necessary by the management during crowded sessions. Such guest tickets shall not be resold and shall be used only for bona fide guests of the Recreation Identification Card holder on the day issued, and such guests shall be accompanied by the Card holder.

(d) (1) During periods when the Ice Rinks are not open for scheduled public use, the Rinks may be rented for private group use subject to approval and scheduling by the City Manager.

The City Manager is authorized to establish and enforce reasonable regulations governing such group use.

(2) The group-use rental charge shall be a maximum of Two Hundred and Seventy Five Dollars (\$275.00) per hour.

(3) No group rental shall be approved unless the group desiring to rent the facility consists of not less than sixty percent (60%) Cleveland Heights residents and is sponsored by an adult resident of Cleveland Heights who is also the holder of a Recreation Identification Card. If no Cleveland Heights group has indicated a desire to rent a rink on a particular date, it will be made available for rent by non-resident groups. Only such sponsor shall negotiate rental and other arrangements. Such sponsor shall be responsible for the payment of rentals and for the conduct of members of the group while so using the Ice Rink and other facilities, shall be personally present during the entire period of such use, and shall be responsible to the City of Cleveland Heights for any injury or damage which may be caused by the group or any member thereof during the period of such use.

(4) The City shall provide to the Cleveland Heights High School Hockey Team rink time for four (4) to six (6) practices a week during the regulation season, pre and post-season practices by arrangement, and rink time for regularly-scheduled home games and tournament games. The City shall receive fifty percent (50%) of the gross gate receipts as rental payment to the City by April 1, 2016.

(5) No group or individual shall act as sponsor for more than one (1) group during the 2014-2015 skating season.

(e) (1) During designated rental times, the City Manager may rent either Rink to non-adult hockey teams for a sum equal to fifty percent (50%) of the gross admission fees charged by such teams for their hockey games or an agreed hourly rate. Such hockey games shall be open to the public, and the admission fee charged shall not exceed the following:

(2) Such other programs and activities shall be presented as are approved by the City Manager and as are within the concept of the general program approved by the City Council. Special promotional fees and discounts may be established for such programs as approved by the City Manager.

(f) A Family Annual Ice Pass shall entitle the following persons in the family to seek admission at any general ice skating session, provided that each individual seeking admission pursuant to such family plan shall also be the owner of an individual Recreation Identification Card:

- Adult head of household and his/her spouse or partner.
- Dependent children occupying the household age 18 and under.

(g) Replacement of a lost or mutilated Individual or Family Pass will be made by the City upon payment to the City of a fee based on the following rates:

Resident and Non-Resident Individual Pass  
or Family Pass.....\$6.00

(h) (1) Private and Group Instruction sessions may be scheduled by the City Manager during appropriate hours not scheduled for public skating sessions.

(2) Groups scheduled for Group Instruction shall be of such number of persons as is approved by the City Manager. Each member of any such group shall be a bona fide resident of the City of Cleveland Heights and the owner of a Recreation Identification Card; provided, however, that the City Manager may authorize any such group to include non-residents.

(3) The fees hereafter established for Group Instruction are based on a six (6) week series of one (1) instruction session per week and shall be adjusted proportionately in the event any such series is scheduled for a greater or lesser number of sessions.

(i) The City Manager is hereby authorized to establish additional rules and regulations not inconsistent with the provisions of this Ordinance which she may, from time to time, deem necessary to provide for the orderly operation of the Ice Rinks and the conduct and protection of the members of the general public using same.

SECTION 2. RATES AND CHARGES - ICE RINKS

The following rates and charges are hereby established for the 2014-2016 season with respect to the Cleveland Heights Community Center Ice Rinks:

(a) Recreation Identification Card.....\$5.00  
( includes digital photo)

(b) Public Skating Session Individual Admission:  
Pre-school children accompanied by a parent or adult (limit of two (2) per parent or adult):

With I.D. and Pass ..... No Charge  
Students (kindergarten through high school) with I.D..... \$2.00/session  
Adults and young adults 18 years of age or older  
not attending high school with I.D..... \$3.00/session  
Any non I.D. card holder ..... \$5.00/session  
Book of ten (10) guest tickets ..... \$45.00  
Book of ten (10) skate rental tickets .....\$16.00

- (c) Annual Ice Pass for Cleveland Heights residents for a 12 month season:  
 ( from date of purchase of pass)
  - Youth / Students  
 (kindergarten through age 11) ..... \$84.00
  - ( age 12 through high school or equivalent) ..... \$110.00
  - Young adults ages 18-24, not attending high school, or equivalent.. \$132.00
  - Adults ages 25-59 .....\$154.00
  - Adults 60 years of age or older.....\$66.00
- (d) Cleveland Heights residents Family Ice Pass.....\$275.00

NOTE: In addition, a separate Recreation Identification Card must be purchased for each participating family member except pre-school children.

- (e) Annual Ice Pass for Non-Residents (12 months):
  - Youth/Students (kindergarten through age 11).....\$210.00
  - Youth/Students (age 12 through high school or equivalent).....\$225.00
  - Young adults (ages 18-24, not attending high school or equivalent).\$250.00
  - Adults, ages 25-59 .....\$325.00
  - Adults 60 years of age or older .....\$150.00
  - Family Pass .....\$625.00
- (f) Private Instruction:
  - Each 15 minutes or fraction thereof..... \$5.50 - \$16.00
- (g) Group Instruction:
  - Cleveland Heights residents with I.D. card ..... \$8.00/Per 2 hour lesson
  - Non-resident with or without pass ..... \$10.00/Per 2 hour lesson

An annual fee of Ten Dollars (\$10.00) may be charged to group lesson participants that the City registers with the U.S.F.S.A.

\* NOTE: A late fee of \$2.00 will be charged to those who register after the designated period for group lessons or general recreation classes.

- (h) Skate Rental (per session).....\$2.00
- (i) Skate Sharpening .....\$5.00
- (j) Locker Rental:
  - Daily - large .....\$ .50
  - Monthly - large .....\$14.00
  - Annual - large .....\$80.00
  - Refundable deposit on locker rentals .....\$10.00
  - Lost locker key.....\$10.00

(l) All Cleveland Heights youth resident participants in the Travel Hockey League shall pay a fee of Two Hundred Forty Dollars (\$240.00) for the regular hockey season which ends in March 2016. All non-resident participants in the Travel Hockey League shall pay a fee of Four Hundred and Forty Dollars (\$440.00). Such fees include the week long Developmental Hockey Camp. Participants must also purchase Recreation I.D. cards (Cleveland Heights residents only).

Priority will be given first to Cleveland Heights residents; then to multi-year participants in the Hockey League; and then to residents of the Cleveland Heights-University Heights school district. (However, all non-residents of Cleveland Heights must pay non-resident fees.) Residents of other communities may participate on a space available, first come - first served basis.

Those wishing to try-out for the Travel Hockey League will be required to pay a non-refundable deposit of One Hundred Dollars (\$100.00) prior to the first try-out session in August 2013. Deposits will be applied to the total fees once the try-outs are completed and teams selected.

(m) In addition, members of the travel hockey teams will be responsible for paying the total costs of entering any team in the Cleveland Suburban Hockey League. The City Manager shall determine the costs per person thereof.

(n) The following rates and charges are hereby established for non-travel youth hockey programs for the 2014-2015 season:

(d) Such other programs and activities shall be presented as are approved by the City Manager and as are within the concept of the general program approved by City Council. Special promotional fees and discounts may be established for such programs as approved by the City Manager.

(e) A Family Fieldhouse Annual Pass shall entitle the following persons in the family to use the Fieldhouse facilities at publicly scheduled times, provided that each such individual shall also be the owner of an individual Recreation Identification Card:

Adult head of household and his/her spouse or partner.

Dependent children occupying the household age 18 and under.

(f) Replacement of a lost or mutilated Annual Family Pass or Recreation I.D. card will be made by the City upon payment to the City of a \$6.00 fee.

(g) Instruction and training on fitness area equipment may be scheduled by the City Manager at times and subject to limitations and policies as the City Manager deems appropriate.

(h) The City Manager is hereby authorized to establish additional rules and regulations not inconsistent with the provisions of this Ordinance which he may, from time to time, deem necessary to provide for the orderly operation of the Fieldhouse and the conduct and protection of the members of the general public using same.

SECTION 4. RATES AND CHARGES B FIELDHOUSE

The following rates and charges are hereby established for the 2015-2016 season with respect to the Cleveland Heights Community Center Fieldhouse:

- (a) Recreation Identification Card..... \$5.00  
(includes digital photo)
- (b) Annual pass for Cleveland Heights residents for a 12 month period (from date of purchase):
  - Youth/students (kindergarten through age 11) ..... \$84.00
  - (age 12 through high school or equivalent) ..... \$110.00
  - Young adults ages 18-24, not attending high school or equivalent ..... \$180.00
  - Adults ages 25-59 ..... \$220.00
  - Adults 60 years of age or older ..... \$115.00
  - Families (adult head of household, his/her spouse or partner and dependent children age 18 and under occupying the household) \$345.00

Note: In addition, a separate Recreation Identification Card must be purchased for each participating family member, except pre-school children.

- (c) Monthly (thirty-day) fieldhouse pass for Cleveland Heights residents:
  - Youth/students (kindergarten through age 11) ..... \$10.00
  - (age 12 through high school or equivalent) ..... \$18.00
  - Young adults ages 18-24, not attending high school or equivalent ..... \$27.00
  - Adults ages 25-59 ..... \$33.00
  - Adults ages 60 or older ..... \$17.00
  - Families (adult head of household, his/her spouse or partner and dependent children age 18 and under occupying the household).... \$55.00
- (d) Fieldhouse guest individual admission - Resident..... \$6.00  
(With a resident holding both an I.D. card and annual Fieldhouse pass)
- (e) Fieldhouse guest individual admission - Non-resident ..... \$8.00  
(With a resident holding both an I.D. card and annual Fieldhouse pass)
- (f) Cleveland Heights residents in the military, who are home on leave, with proof of residency may pay a fee of \$3.00 a day per individual or \$6.00 per family to use the Fieldhouse.

(g) Non-residents who: (1) Live within the boundaries of the Cleveland Heights-University Heights School District; (2) Are employed within the boundaries of the City of Cleveland Heights; or (3) Have children in the Community Center Programs.

(i) Child Supervision (for members only)

Fee: \$3.00 an hour or a \$20 punch card for ten hours. Times to be determined.

SECTION 5. RATES AND CHARGES - ADULT & YOUTH SPORTS LEAGUES, MISCELLANEOUS

(a) The following rates and charges are hereby established with respect to adult and youth sports leagues for the 2014-2015 fall/winter season and until such time as new rates and charges are established:

(1) Men's Hockey

Resident..... \$160.00/one program

Non-Resident..... \$250.00/one program

(2) Women's and/or Co-ed Hockey

Resident..... \$160.00

Non-Resident.....\$250.00

(3) Adult Basketball (Men, Women )

Resident Team.....\$300.00\*

Non-Resident Team.....\$350.00\*

(4) Youth Basketball

(b) \*A refundable (\$78.00) forfeit fee will also be charged to each adult softball team.

(c) An adult “resident team” is defined as a team with at least 60% Cleveland Heights residents.

(d) Except as otherwise provided herein, when any new recreational program, activity or class in the Community Center or parks is offered which requires the use of materials and/or personal services, the City Manager shall determine the costs of such program and shall establish a fee for such program for each participant, with such total fees not to exceed the estimated expenditure for said program for a minimum enrollment. Fees may range from Zero (\$0.00) to One Hundred Eighty Dollars (\$180.00) per program, and all fees shall be paid by each registrant at the time of registration.

(e) The City Manager shall establish the fees for room rentals and equipment rentals at the Community Center and shall establish and enforce reasonable rules and regulations governing such rentals.

SECTION 6. Ordinance No. 95-2014 adopted on August 6, 2014, is hereby repealed to the extent inconsistent herewith.

SECTION 7. Notice of the passage of this Ordinance shall be given by publishing the title and abstract of contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights.

SECTION 8. This Ordinance shall take effect and be in force at the earliest time possible permitted by law September 1, 2015.
